## Corrigendum to Draft Notification: No. \_\_\_\_\_of 2013

In exercise of Powers conferred under section 61, 86 and 181 of the Electricity Act, 2003 (Act No. 36 of 2003) and all other powers enabling it in this behalf, and after previous publication, the Gujarat Electricity Regulatory Commission hereby makes the following regulations, to amend Gujarat Electricity Regulatory Commission (Procurement of Energy from Renewable Sources) Regulations, 2010 (hereinafter referred to as "The Principal Regulations") namely:

- 1) The Commission issued draft amended notification on 6.11.2013 in exercise of Powers conferred under section 61, 86 and 181 of the Electricity Act, 2003 (Act No. 36 of 2003) and all other powers enabling it in this behalf, and after previous publication, the Gujarat Electricity Regulatory Commission hereby makes the following regulations, to amend Gujarat Electricity Regulatory Commission (Procurement of Energy from Renewable Sources) Regulations, 2010 (hereinafter referred to as "The Principal Regulations").
- 2) The Commission has issued the public notice in English and Gujarati News Papers on 6.11.2013 and inviting comments and suggestions from the Stakeholders on or before 8.12.2013.

3) On verification of the documents on record of the above draft amended regulations, a typographical error has been observed on page No. 2 of the draft Regulations, which is a Substitution of Table 1 of Regulation 4.1 of the principal Regulations. It is, therefore necessary to correct the said typographical errors in the draft notification dated 06.11.2013. We, therefore, decide to correct the above stated error and put up the corrected draft for corrections in Table 1 of Regulations 4.1 as stated below:
