We, therefore, decide and direct the Petitioner to amend the memo of parties in the present Petition by impleading State Transmission Utility, namely, Gujarat Energy Transmission Corporation Limited, State Load Despatch Centre and GEDA which is the Nodal Agency in the present matter by arraying them as Respondents in amended memo of parties and thereafter, file the same with the Commission and also serve



the copy of the amended Petition to the aforesaid Respondents and thereafter, file an affidavit of service to the Commission.

4. In compliance to the above directive issued by Hon'ble Commission, the Petitioner is filing herewith the amended Memo of Parties arraying (i) Gujarat Energy Transmission Corporation Limited (GETCO), (ii) State Load Despatch Centre (SLDC) and Gujarat Energy Development Agency (GEDA) as Respondents to the Petition.

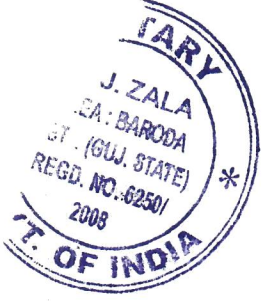
5. It is, therefore, respectfully prayed that this Hon'ble Commission may be pleased to:

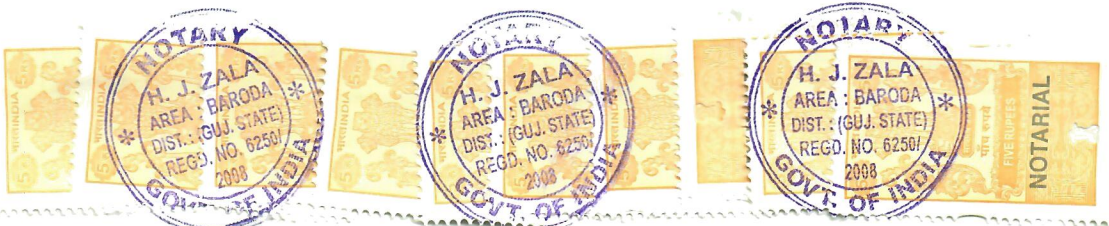
