

Dissent against govt not seditious: SC scraps plea citing Farooq on Art 370

THE SUPREME COURT Wednesday dismissed a plea seeking seclusion charges under Section 124A of the Indian Penal Code against former Jammu and Kashmir Chief Minister Farooq Abdullah over some of his past remarks after the abrogation of Article 370 of the Constitution stating that "the expression of a view which is dissent from a decision taken by the Central government cannot be said to be seditious".

Justice Chandrachud said he found so offensive as to give a ground for action for a court to initiate proceedings. "I added that 'the petitioners have nothing to do with the subject matter and this is clearly a case of publicity interest litigation for the petitioners only to get their names in the limelight'. "We discourage such endeavours," said the bench which went on to dismiss the petition and imposed a cost of Rs 50,000

on petitioners Rajat Sharma, Secretary and Trustee, Viswa Guru Vidya Vision of Saurat Patel; and Uttar Pradesh resident Neh Srivastava. The fine is to be deposited with the SC. Advocates Welfare Fund within four weeks. The petition said that on October 11, 2020, Abdullah, who is a Member of Parliament, and President of National Conference, had on live TV said that "my property tumhare baap ka nahai hai and (that) he will get Article 370 restored with the help of China". The plea added that the National Conference had stated that Abdullah had "never said" anything to the effect of involving China.

The plea also referred to BJP spokesperson Sanjay Patra's remarks critiquing Abdullah over the said comments. The petitioners said the former J&K minister is "seditious" and that "he is propagating anti-national thoughts in the mind of innocent people of Jammu and Kashmir... and he deserves to be removed from the membership of Parliament". The apex court's observations come amid growing criticism of the government over the recent use of this national provision to quash dissent. The top court has also had the occasion to deal with petitions in which the provision has been invoked, some of them still pending.

Ghosh's name also doing round, BJP to finalise list for first 2 phases today

WEST BENGAL BJP president Dilip Ghosh on Wednesday said that the party's state unit has shortlisted an average of four or five names per seat for the initial two phases of polling in the state and the list of candidates for those phases will be finalised on Thursday.

seats. Polling will be held in 30 seats each on March 27 and April 1. One of the constituencies going to polls in the second phase is Nadirgram, from where Trinamool Congress chief and Chief Minister Mamata Banerjee is scheduled to contest. "We have received 120-140 names from our district units for the first two phases. In addition to that, there are hundreds of other names. We had 20-25 names

for each seat and from that, we have shortlisted around four-five names per seat," Ghosh told reporters. "There will be some omission and after that, it is for the party leadership to decide." He said, "This reflects that people from various walks of life are very eager to join us."

Besides the 19 TMC MLAs, including former ministers Rajib Banerjee and Suwendu Adhikari who are most likely to get tickets from their old constituencies, the saffron camp is also expected to nominate several personalities from the Bengali film industry.

'Why Samajwadi tagged to every criminal': Yogi tries to put SP in dock

UTTAR PRADESH Chief Minister Yogi Adityanath on Wednesday sought to turn the tables on the Samajwadi Party (SP) over law and order situation in the state, asking why the word 'Samajwadi' gets tagged to "every criminal". Speaking in the Assembly, Adityanath, referred to the Hathras incident in which a man on bail after his 2018 arrest in a molestation case allegedly shot dead the victim's father. The state BJP has been pointing at Facebook account, which it claims identifies that the accused is a Samajwadi Party worker.

as Ram Manohar Lohia and Chandrasekhar, has now become impractical, but its leaders are not ready to accept the truth. He asked about the "topiwala" who has figured on social media, in an apparent reference to the man in a cap who the BJP says is the SP worker accused in the Hathras case. "The Hathras incident has yesterday once again put the 'topiwala' in the dock," Adityanath said, in an indirect reference to the red caps SP workers and leaders wear. "Has the Samajwadi Party no link with the criminal as far as the unfortunate incident of Hathras is concerned? Why is it that the word 'Samajwadi' is associated with every criminal?" Indirectly, he also referred to the purported SP worker canvassing support for a party rally. "What does this prove,"

the CM asked. "You have made the socialist movement an aqwabhaik (unnatural), aqwabhaik (impractical) and amanuviya (inhuman) movement. Hence, people are talking of things about it," he said. Adityanath's remarks came after a 50-year-old man was allegedly shot dead in Hathras district on Monday by Gaurav Sharma, who is accused of molesting the victim's daughter. Earlier, the CM ordered submission of the case and directed officials to invoke the NSA.
