In the matter of:

<u>Determination of Average Pooled Power Purchase Cost (APPC) for the Financial Year 2020-21 – reg.</u>

1. The GERC (Procurement of Power from Renewable Energy Sources) (First Amendment) Regulations, 2014 provides for determination of APPC on annual basis. The relevant regulations of the said Regulations are reproduced below:

"2.1 (aa) 'Average Power Purchase Cost' means the weighted average pooled price at which the distribution licensee has purchased the electricity including cost of self-generation, if any, in the previous year from all the energy suppliers long-term and short-term, but excluding those based on renewable energy sources, as the case may be."

"5.4: The Commission shall determine the 'Average Power Purchase Cost' of the distribution licensee concerned on annual basis. The Average Power Purchase Cost determined by the Commission shall be required to be paid by the distribution licensee when the distribution licensee purchases the electrical component of the renewable energy projects registered under the REC scheme notified by the Central Electricity Regulatory Commission."

- 2. The Commission vide Order No. 2 of 2021 dated 26.03.2021 has determined the Average Pooled Power Purchase Cost (APPC) for FY 2018-19, applicable for FY 2019-20 for different licensees separately.
- 3. The Commission now determines the APPC for the year 2019-20, applicable for FY 2020-21. The state has different distribution licensees which are purchasing different quantum of electricity at different price from different sources. Hence, the APPC is determined for different licensees separately. Since the licensees such as Jubilant Infrastructure and Aspenpark Infra procured power from the State distribution licensees, the APPC of these licensees are not determined.

Hence, the following order:

ORDER

4. In exercise of the powers conferred under Clause 5.4 of the GERC (Procurement of Energy from Renewable Sources) (First Amendment) Regulations, 2014, the Gujarat Electricity Regulatory Commission hereby determines the APPC for FY 2019-20, applicable for FY 2020-21 for different licensees separately, as tabulated below:
