

26-year-old engineer gangraped in Jharkhand

A 26-year-old software engineer was allegedly gangraped in Chaibasa area of West Singhbhum district in Jharkhand, police said on Saturday.

According to the police, the incident happened at a secluded place near the old airport in Chaibasa on Thursday evening when she was out with a male friend. West Singhbhum Superintendant of Police Ashutosh Shekhar said a case has been registered at the Mufasil police station and an investigation is underway to identify the accused.

He said: "The woman works

for a Bangalore-based IT company and was here as she was working from home. The incident happened around two kilometres away from her village. We have rounded up some suspects from neighbouring villages. There is a possibility that the accused may know the girl. We are investigating the case."

The police said the accused had beaten up the woman's friend and allegedly raped her after taking her to a secluded spot. They also took away her belongings, including phone, they said. The woman managed to reach home and told her family about the incident after which they filed a police complaint. The BJP demanded CM Hernant Soren's resignation over the incident.

UNION HOME Minister Amit Shah held closed-door meetings with the party leaders of seven districts in South Gujarat Saturday. The meeting, which was held at Shree Saurashtra Kadva Patidar Samajwadi in Valsad, was also attended by Chief Minister Bhupendra Patel, state BJP president C R Paatl and cabinet ministers.

BJP district presidents and party leaders, MLAs from different Surat, Valsad, Navsari, Tapi, Dangs and Bharuch participated

in the meeting. This is the first of a slew of meetings he is scheduled to hold during his five-day state tour to review preparations for the Assembly elections. Incidentally, the first meeting, held in Valsad, coincided with Shah's birthday Saturday.

There was a detailed discussion on mobilising page committees, ward committees and page pramukh and other wings presenters and members for the elections, said a party source. The leaders were directed to publicise the importance of the Central and state government schemes and their benefits.

Talking to reporters, Shah said preparations for the Assembly election for seats in south Gujarat zone were complete, right from micro-planning to election and booth management and victory processions.

Shah started with south Gujarat, and will meet leaders of the central zone in Vadodara on Sunday. Paatl and the chief minister will also be present in the meeting tomorrow, as per details of the event shared by the BJP.

GCCI writes to top cop over functioning of hotels

THE GUJARAT Chamber of Commerce and Industry (GCCI) Saturday wrote to the Ahmedabad city police commissioner requesting issuance of clarification guidelines to police officers to allow smooth operations of hotels and restaurant businesses during the festive season.

GCCI president Pathik Patwari, in his representation to city police commissioner Sanjay Shrivastava, wrote that while hotels and restaurants have been allowed to operate 24 hours for seven days, police officers on duty are forcing them to shut down their operations at night, which in turn is causing "huge loss of business."

Additionally, it has been pointed out that in many cases,

there is "unnecessary involvement by the department officers and undue documentation, fines and penalty" are being insisted upon despite such businesses adhering to relevant rules and laws.

Citing one such example, the representation notes, "many a times issues are raised with respect to the information printed in the packaging, weight of product, MRP printed on the package etc. Even

though established organisations have been allowed to keep the product price more than MRP as per... High Court's order, the officers are not allowing the same and charging exorbitant fines."

The representation has appealed to the authority to issue necessary clarificatory orders in this regard so that businesses don't face "undue hardships during this Diwali festive season."
