THE PETITIONER RESPECTFULLY SUBMITS AS UNDER:

"GIFT Power Company Limited" (hereinafter referred to as "GIFT PCL" or "Petitioner"), files the present Petition regarding RPO Compliance for FY 2021-22.



1. GIFT Power Company Ltd (GIFT PCL) is a 100% subsidiary company of Gujarat International Finance Tec-city Company Limited (GIFT CL) incorporated under the provisions of the Companies Act 1956 having its registered office at EPS - Building no. 49A, Block 49, Zone 04, Gyan Marg, GIFT City, Gandhinagar. GIFT PCL is a distribution licensee for the supply of electricity in the GIFT City area. The Hon'ble Gujarat Electricity Regulatory Commission (hereinafter referred as "Commission" or "GERC") granted the license for distribution of electricity vide its order dated 6th March, 2013 as per License Application No 1/2012 to GIFT Power Company Limited, for catering the power requirement of GIFT City which includes both Domestic Tariff Area (DTA) and Special Economic Zone (SEZ) Area.
2. The Hon'ble Commission in exercise of the powers conferred under Sections 61, 66, 86 (1) (e) and 181 of the Electricity Act 2003 (36 of 2003), has framed the GERC (Procurement of Energy from Renewable Sources) Regulations, 2010 for promoting sale of power from renewable energy sources to any consumer and for procurement of energy from renewable sources by distribution licensee within the State of Gujarat vide its Notification No. 03 of 2010 dated 17th April, 2010 (hereinafter referred to as RPO Regulations). In the RPO Regulations, the Hon'ble Commission has specified the minimum percentage for procurement of power from Wind, Solar and Other Sources. Subsequently, the Hon'ble Commission issued the Gujarat Electricity Regulatory Commission (Procurement of Energy from Renewable Sources) (First Amendment) Regulations, 2014. Consequently, the Hon'ble Commission has also notified the Gujarat Electricity Regulatory Commission (Procurement of Energy from Renewable Sources) (Second Amendment) Regulations, 2018 vide Notification No. 1 of 2018 dated 23rd April-2018.
3. As per the aforesaid regulation, the RPO target specified by the Hon'ble Commission to be fulfilled by the obligated entities during FY 2021-22 is furnished below:

4. Petitioner's licensee area is a green field developing area and power requirement has been increasing over past couple of years. At present, the base load of Petitioner is ~3 MW and the peak load is around ~7.5 MW. The same is expected to be increased to ~5 MW & ~12 MW respectively by 2024-25.
5. The Volume of Power Purchase transacted by Petitioner is quite low and is almost negligible when compared to other distribution licensees. Hence, it was difficult for Petitioner to source power through renewables at a competitive rate as Renewable Purchase Obligation quantum was very less due to small consumer base/demand.
6. As approved in the Tariff Order dated 1st April-2021 (Case No. 1942 of 2021), the Petitioner had decided to purchase Renewable Energy from Power Exchanges at Rs. 4.00/Unit under G-TAM and G-DAM segments. Also, the Petitioner had estimated partial compliance from Solar PV Plants installed in licensee area under Net-Metering Arrangement.
7. The Petitioner has fulfilled RPO Compliance partially during FY 2021-22, due to reasons beyond Petitioner's control and the same are mentioned below:
 - a) Based on the directions of Hon'ble Commission in Tariff Order, Petitioner has made efforts to purchase renewable energy via G-TAM/G-DAM segments in Power Exchanges at landed cost of Rs. 4.00/Unit but was unsuccessful due to low trading volume and high clearing prices.
 - b) The Renewable Generators are bidding on a premium of rates w.r.to rates discovered at DAM segment based on market dynamics which became unviable to the Petitioner to source through G-TAM/G-DAM segments. The average price discovered from April-2021 to March-2022 in various segments in Power Exchange (IEX) is furnished below:

c) Both G-TAM/G-DAM segments are relatively new market segments compared to Conventional DAM segment. The G-TAM segment was launched on 21st August-2020 and G-DAM segment was launched on 27th October-2021, whereas the DAM segment was existent since year 2008. The liquidity in sell side of G-TAM/G-DAM segment was quite minimal due to availability of 10 to 12 RE Generators whereas the demand in purchase side was higher than normal.

8. Accordingly, the Petitioner has attempted to purchase renewable energy through G-TAM/G-DAM segments in IEX at a competitive rate whenever possible during FY 2021-22. The RE generators were selling power on premium basis or to a pre-decided buyer on a specific rate by spot trading. The Summary of category-wise and month-wise details of successful RE purchase are furnished below:

9. Based on the above representation, Petitioner has considered renewable energy procurement of 3,81,306 Units while accounting RPO for FY 2021-22.
10. The Petitioner would like to submit that Distributed Solar PV Plants are operational in the licensee area and all of them are owned by Consumers under Net-Metering arrangement. The Total Capacity of such Solar PV Plants installed in licensee area is furnished below:

12. The energy generated from the Solar Plants installed by Consumers in the Petitioner's licensee area under net metering arrangement i.e., 3,36,366 Units is being taken into consideration while submitting the details of RPO Compliance during FY 2021-22.

14. The Status of RPO Compliance during FY 2021-22 is tabulated below:

15. Based on the aforementioned backdrop, it is observed that the RPO quantum is quite low. Therefore, no generator has agreed for supply of such quantum at competitive rate on PPA arrangement. After exercising commercial prudence, it was decided to purchase renewable energy from G-TAM/G-DAM segments on Power Exchanges as directed by Hon'ble Commission in Tariff Order.
16. The Petitioner submits that it had made sincere efforts to source maximum renewable energy from G-TAM/G-DAM segments whenever the rate is competitive (i.e., Rs. 4.00/Unit or lesser price than DAM Segment) but was successful only during few months in FY 2021-22 due to supply constraints.
17. Petitioner was in an opinion that, purchase of RE at very high rate would increase the power purchase cost of the Petitioner and consequently increase the cost of supply which would again result in increase of financial burden to the Consumers.
18. As per the GERC Principal Regulations on Procurement of Energy from Renewable Sources-2010, the Petitioner requests Hon'ble Commission to kindly revise the RPO target for compliance in FY 2021-22 due to supply constraints in G-TAM/G-DAM segments and through PPA arrangement. This request is being prayed in accordance with the Regulation 4.2 of the Principal RPO Regulations. The excerpt from the clauses reads as follows:
- "4.2 The Commission may, suo-motu or at the request of a licensee, revise the percentage targets for a year as per clause 4.1 of these Regulations keeping in view supply constraints or other factors beyond the control of the licensee."*
19. The RPO regulations confers the power to Hon'ble Commission for revising the RPO target based on the request of the licensee on account of supply constraints or due to other factors beyond the control of the licensee.
20. Subsequently, keeping in view of the above mentioned points the Petitioner humbly requests the Hon'ble Commission to revise the RPO targets and kindly exempt us from RPO Compliance of FY 2021-22 due to low RPO quantum and considering the factors of supply constraints in G-TAM/G-DAM segments on Power Exchanges.



Prayers

Based on the facts and circumstances mentioned in this Petition, the Petitioner humbly prays this Hon'ble Commission:

- a. To admit the present Petition for further necessary process.
- b. To revise the RPO targets and exempt the Petitioner for RPO Compliance during FY 2021-22.
- c. To allow additions/ alterations/ changes modifications to the application at a future date.
- d. Allow any other relief, order or direction, which the Hon'ble Commission deems fit to be issued.
- e. Condone any inadvertent omissions/errors/shortcomings and permit the Petitioner to add/change/modify/alter this filing and make further submissions as may be required at a future date.
- f. To afford the reasonable opportunity of personal hearing to the Petitioner before passing any orders in the matter.
- g. To grant any relief/s as it deems fit and appropriate under the circumstances of the case and in the interest of justice.

Declaration that the subject matter of the Petition has not been raised by the Petitioner before any other competent forum, and that no other competent forum is currently seized of the matter or has passed any orders in relation thereto.

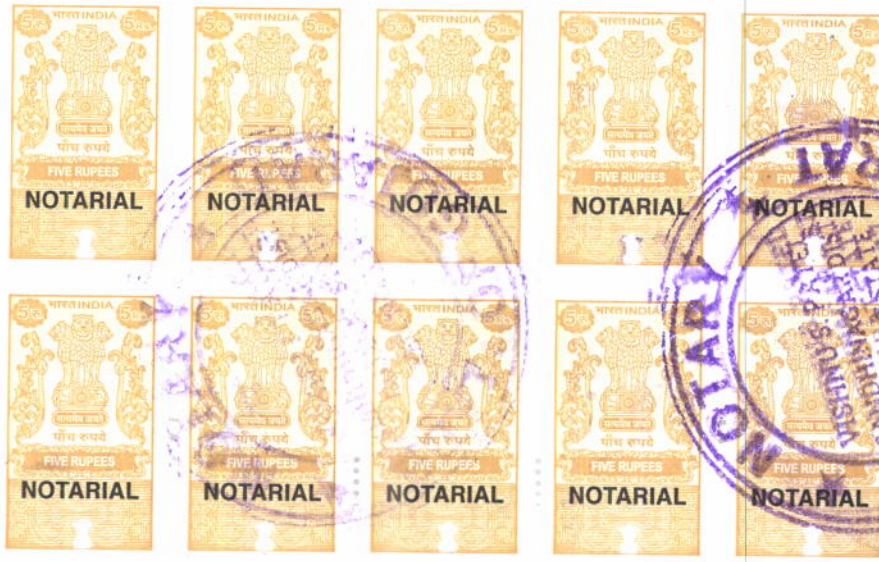

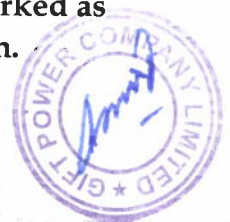
SUBMISSION
