A DHABA in Ropar, where an Army Major and his fellow soldiers were lastly beaten up by the eatery's workers and his owner on Monday, has been sealed and four accused have been arrested, Punjab Police Thursday said.

Six Army personnel, who had suffered injuries in the incident were given first aid at Ropar and later transferred to Command Hospital at Chandimandir. The police said the Army personnel showed remarkable restraint in not escalating the issue.

Later based on further evidence a supplementary FIR had been lodged under Section 397 of the IPC as also naming prime suspects.
