### SALUTE THE SOLDIER

Captain SC Sehgal, V/C Chakras Posthumously  
On 16 December 1971, during the Indo-Pak War, Capt SC Sehgal exemplified unparalleled courage and devotion to duty as the Forward Observation Post Officer with an Amnoured Regiment in the Shakarganj Sector (Samba, J&K). Amid heavy enemy fire, he skillfully directed medium artillery units to neutralize a concentrated enemy tank formation. When his own tank was struck and engulfed in flames, Capt Sehgal, with complete disregard for his own safety, worked heroically to rescue the trapped driver and gunner. Tragically, while performing this selfless act, he was fatally wounded by enemy machinegun fire. In recognition of his extraordinary bravery and supreme sacrifice, Capt SC Sehgal was awarded the Vir Chakra posthumously.
