

# Battle of cousins: BRS suspends KCR daughter Kavitha from party

'Anti-Party Acts, Recent Attitude' Cited

Hyderabad: The battle of cousins within former Telangana CM K Chandrababtu Naidu's BRS claimed its biggest casualty Tuesday when a disciplinary committee suspended his daughter and MLC K Kavitha from the party for an unspecified period, citing her "recent attitude and anti-party activities".

The implosion, which BJP attributed to a tussle among KCR's kin for the alleged spoils of the Kaleshwaram project scam, came a day after Kavitha publicly named her father's two influential nephews — former minister Harish Rao and ex-Rajya Sabha MP Joginapally Santosh Kumar — as being among the beneficiaries of corruption. But for the duo's alleged mis-

## HC grants interim protection to KCR

Telangana HC on Tuesday granted interim protection to BRS chief K Chandrababtu Naidu and former minister T Harish Rao from "any adverse action" based on the Justice P C Ghose Commission's report, until further orders, reports Pinto Deepak. The bench clarified CBI would conduct an investigation independently.

While Kavitha's family, including her brother and former minister KT Rama Rao, remained mum, another ex-minister, Satyavathi Rathore, told reporters her "imminent exit" would have no bearing on BRS. Other functionaries said KCR didn't see any difference between his family members in politics and the party's rank and file.

Sources close to Kavitha said she would soon decide on whether to remain a legislative council member or resign. Speculation is rife that she might launch a party. Telangana BJP chief N Ramchander Rao said Kavitha's remarks against her own party reflected a family feud over "ill-gotten wealth". Congress said her suspension after an outburst against her own was proof of wrongdoing in the Kaleshwaram case.

Kavitha's unease over her position in BRS became public in May after a letter she had written to her father was leaked to the media. She subsequently spoke of "ghosts around KCR".

While Kavitha's family, including her brother and former minister KT Rama Rao, remained mum, another ex-minister, Satyavathi Rathore, told reporters her "imminent exit" would have no bearing on BRS. Other functionaries said KCR didn't see any difference between his family members in politics and the party's rank and file.

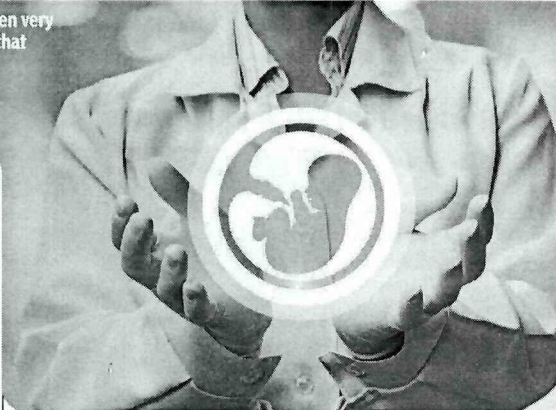
85% were not aware of ovulatory periods in the menstrual cycle

### LOW OVARIAN RESERVE

● Ovarian reserve is the number of oocytes (immature eggs) in a woman's ovaries. It decreases with age or due to smoking, surgery or exposure to endocrine-disrupting chemicals found in plastics, pesticides

● To know their ovarian reserve, women can undergo a marker test to determine levels of Antimüllerian hormone (AMH)

● Senior IVF specialist from the city, Dr. Firuz Parikh, analysed lab data of over 50,000 women and found a faster rate of decline in AMH levels with age in healthy Indian women as compared to Caucasian women (Journal of Human Reproductive Sciences, 2021)

### SOCIAL MEDIA AS FERTILITY ADVISOR

A new survey done by Motherhood Hospital and Nova IVF among 23- to 30-year olds found:

- 51% of the respondents were unaware of AMH levels
- 18% tested their AMH levels, while 82% didn't
- 41% sourced fertility information from social media, 23% from friends, 14% from family & 12% from TV shows/movies
- 40% planned pregnancy between 28-32 years (another 29% prefer 33-36 years)
- 56% have heard of egg freezing but feel they don't know enough

## Can person shoot himself in chest with rifle, SC asks MP

New Delhi: Is it possible for a person to shoot themselves in the chest with a rifle? SC raised this question while wondering whether the death of a man, who died in similar circumstances, was really a case of suicide as alleged by the prosecution or one of murder.

Hearing a plea against anticipatory bail granted to an accused who is facing an abetment of suicide charge, a bench of justices Manoj Misra and Ujjal Bhuyan sought MP govt's response on whether the case was probed from all angles, raising doubts on police report that it was suicide.

"To our understanding, whether a person would be able to use a rifle to shoot himself on the chest needs examination. In such circumstances, we deem it appropriate to re-

high court granted anticipatory bail to the accused under IPC Section 306.

"Such affidavits shall be filed within a period of two weeks. Along with the affidavit, the autopsy report of the deceased as well as the material collected during investigation, particularly in respect of seizure and length of the rifle, shall be disclosed/filed," SC said. TNN

## Scores line up to adopt newborn left in garbage van

Bhopal: Her biological parents didn't want her. Now, compassionate strangers are beeline to give her a home. Abandoned at birth, sanitation workers found this newborn girl in a garbage collection van on Aug 29 in Bareilly in MP's Raipur district. Three days after she made a miraculous recovery, at least a hundred have come forward, eager to adopt her.

The infant's 30-year-old mother, who had dumped her in a garbage bin, was arrested Sunday. She had given birth out of wedlock and told police the baby's father had forced her to abandon the child. He was arrested Monday.

"The little one's plight shocked and saddened me. I wish to adopt her and give her a happy life," said Rajendra Rai (57), a father of two who runs a hotel in Bareilly. He went to the local police station, where officials told him about the adoption process. "I will discuss it with my wife, who has often expressed her wish to adopt. We will travel to Bhopal and apply for adoption if needed," Rai added.

Like him, hundreds have so far reached out to officials, approaching the doctors treating the baby local police personnel, and Raipur district child welfare committee. "I have received inquiries from at least a hundred people. Many, including the local corporator, expressed the desire to adopt the girl. I, too, wanted to adopt her as we are a childless couple. To my surprise, there were already so many waiting at the CWC office. Even two nurses of the hospital expressed their wish to adopt her," said Dr Hemant Yadav, block medical officer at Bareilly CHC.

"I have been explaining the norms and processes to people, from the CWC to the State Adoption Resource Agency," Dr Yadav added.

Police officials, too, are facing queries. "Around a dozen people have approached us. People are reaching out wherever they think they can get help. We are explaining the norms to everyone," said Bareilly PS in-charge Kapil Gupta.

Apart from locals, people from other parts of the district also wish to adopt the infant.

## Reds kill 2 'police informers' in Sukma, send warning to locals

Raipur: Maoists killed two men in Sukma district in Chhattisgarh's Bastar division early Tuesday. A leaflet recovered from the spot accused them of being police informers, and alleged the duo had been in contact with security forces since 2022.

The bodies of Padam Poja (24) and Padam Devendra (28) were found on the outskirts of Nandapara village. The murders took this year's civilian death toll in Maoist violence in Bastar to 35.

Kerlapal area committee cadres in Darbha division claimed responsibility for the killings in the leaflet, which also named a DRG force jawan whom Maoists termed a "traitor", claiming the two had been passing on information to him.

The leaflet threatened locals against working with police, warning that they would not be spared.

"A team was sent to the spot for investigation. The case is being probed," Sukma SP Kiran Chavan said.

Tuesday's double murder followed a series of attacks on civilians whom Maoists accused of aiding police. On Aug 27, a shikshadoot (volunteer teacher) was killed in Sukma. TNN

## Cheque bounce convict can make deal, avoid jail: SC

New Delhi: A person can avoid a jail term after being convicted in a cheque bounce case if they reach a compromise with the complainant, Supreme Court said on Tuesday, holding that once a compromise deed is signed between the parties, conviction under Section 138 of Negotiable Instruments Act cannot be sustained.

A bench of justices Aravind Kumar and Sandeep Mehta said the offence of dishonour of cheque was mainly a civil wrong and had been made specifically compoundable.

"This court referred the offence under Section 138 NI Act as a Civil Wrong in Criminal Law's Clothing which meant issues agitated by the parties under the said provision are of private nature which are brought within the sweep of criminality jurisdiction in order to strengthen the credibility of the negotiable instruments," the bench said while referring to an earlier verdict of the apex court.

The court set aside a Punjab and Haryana HC ruling that had refused to quash conviction in a cheque dishonour case after settlement between the parties.

SC said when parties enter into an agreement and compound the offence, they do so to save themselves from the process of litigation. Hence, courts cannot override such compounding and impose its will, it said.

"Once the complainant has signed the compromise deed accepting the amount in full and final settlement of the default sum, the proceedings under Section 138 of the NI Act cannot hold water; therefore, the concurrent conviction rendered by the courts below has to be set aside," SC said.

"Therefore it is very clear that although dishonour of cheque entails criminal consequence... The legislature by virtue of Section 147 of NI Act has made it compoundable notwithstanding provisions of Code of Criminal Procedure, 1973," it said

## DNA tests shouldn't be ordered on demand: HC

Bengaluru: The Karnataka HC has ruled that courts must not allow DNA tests on demand unless the strict conditions laid down in Section 112 of the Evidence Act are met.

Justice M Nagaprasanna delivered the judgment while quashing a Channarayana civil court order that had authorised a DNA test in a partition dispute involving the sons of ACSanne Gowda.

The judge underlined that compelling such tests without legal necessity undermines the sanctity of marriage and the legitimacy of a child. He said it also violates the fundamental rights to privacy and dignity guaranteed under Article 21 of the Constitution.

Section 112 of the Evidence Act is based on the maxim "pater est quem nuptiae demonstrant" (the father is he whom the marriage indicates), presuming the legitimacy of a child born during lawful wedlock. A DNA test, the court held, can be ordered only when non-access during the relevant period is both pleaded and proved, since the presumption of legitimacy is rooted in public morality and societal peace.
