## **GUJARAT ELECTRICITY REGULATORY COMMISSION AHMEDABAD**

### **Annual Accounts and Audit Certificate thereon for the year 2003-04**

#### **1. Introduction :**

Gujarat Electricity Regulatory Commission has been constituted under Section 17 of the Electricity Regulatory Commission Act. 1998 by the Government of Gujarat and the same has been deemed to be first Commission established under Sub-Section (1) of Gujarat Electricity Industry (Reorganisation and Regulation) Act, 2003. Further the same Commission along with its staff shall continue to hold office on the same terms and conditions on which they were appointed under those Act. in term of Section 82 of "The Electricity Act-2003" (36 of 2003).

The Gujarat Electricity Regulatory Commission (Budget, Annual Statement of Accounts and Annual Report) Rules, 2003 has been notified vide GHU-03-52-GERC-2003-7977-K Dated 18<sup>th</sup> October 2003 in exercise of the powers conferred by clauses (f), (g) and (h) of the sub-section (2) of section 64 read with sections 46, 47 and 48 of the Gujarat Electricity Industry (Reorganisation and Regulations) Act, 2003 (Guj-24).

The Commission has started its functioning from 1-04-1999 and this is the 5th Financial Year Report for the year 2003-04 is submitted herewith.

#### **2. Budget of the Commission :**

**2.1** The Commission as per Section 106 of the Electricity Act-2003 has prepared in such form and as such time in each Financial Year as prescribed by the Government of Gujarat its Budget for the Financial year 2003-04 showing the estimated receipts and expenditure and forwarded the same to the State Government.

**2.2** This is the Fifth Financial year of the Commission. The Budget provision was kept at Rs. 2.25 Crores under Major Head 2801-Power-800-Other Expenditure Sub-head (8).

**2.3** The Expenditure of the Commission including all salaries and allowances payable to or in respect of the Chairperson and the Members and staff is to be charged upon the consolidated fund of Gujarat.

#### **3. Accounts and Audit of the Commission :**

**3.1** According to Section 104 of the Electricity Act, 2003, the Commission is maintaining accounts and other relevant records and preparing Annual Statements of Accounts in such a form as prescribed by the State Government in consultation with the Comptroller & Auditor General of India. The procedure, formats etc. has been



approved by the State Government in consultation with the Comptroller and Auditor General and communicated by the State Government vide the notification No GHU-03-52GERC-2003-7977-K dated 18<sup>th</sup> October 2003.

3.2 The Accounts of the Commission have been audited by the Comptroller & Auditor General of India for the Financial Year 2003-04. The expenditure incurred in connection with such audit fee is to be paid by the Commission to the Comptroller & Auditor General of India. Such fees for the Year 2003-04 amounting to Rs. 6,525/- has been paid to the State Accountant General.

3.3 The Commission was allocated a budget of Rs. 2.25 Crores during the year 2003-04. As against this the grant of Rs. 1.31 Crores was released by the State Government. According to Section 15 (2) of Gujarat Act, the Commission is empowered to levy Consent Fees while giving the Consent to Captive Power Producers & D. G. Sets owners. During the financial year the Commission had given the Consent in 643 cases and collected consent fee amounting to Rs. 84.72 Lakhs. The total fund so available during the financial year was Rs. 2.16 Crores and as against this the total expenditure of Rs. 1.27 Crores was incurred by the Commission.

3.4 In exercise of powers conferred by Section 103 and Section 180(g) of the Electricity Act, 2003, the Government of Gujarat framed the scheme for the purpose of constituting fund 'The State Electricity Regulatory Commission Fund' and for getting approval the draft Rules are framed and sent to the Government for approval.

3.5 The State Accountant General (Audit)-I Ahmedabad had audited the accounts of the Commission for the year 2003-04 during July-2004. The Commission has received Audit Report together with Audit Certificate from the Accountant General, Ahmedabad. And the same are placed at Appendix-B and Appendix-C respectively.



## APPENDIX - B

### **Audit Report of the Comptroller and Auditor General of India on the accounts of Gujarat Electricity Regulatory Commission, Ahmedabad for the year ended 31 March 2004.**

#### **1. Introduction :**

The Gujarat Electricity Regulatory Commission, (Commission) Ahmedabad was established under Section 17 (1) of the Electricity Regulatory Commission Act, 1998. It started functioning from 19-4-1999.

The audit of the accounts of the Commission has been conducted under Section 19 (2) of the Comptroller and Auditor General's (Duties, Powers and Conditions of Service) Act, 1971 read with Section 34 (3) of the Electricity Regulatory Commission Act, 1998.

The Commission is financed by the State Government through provision in the Budget which is charged on the Consolidated Fund of the State Government. During the year 2003-04 Commission received Rs.131.25 Lakh from the State Government.

#### **2. Organisational Set-up :**

The Commission comprises of a Chairman and two Members. The Chairman is assisted by Secretary, Joint Director, Five Dy. Directors and Accounts Officer for regular functioning of the office.

#### **3. Comments on Accounts :**

##### **Form of Accounts**

In accordance with Section 34 (1) of the Electricity Regulatory Commission Act, 1998, the Commission shall prepare an Annual Statement of Accounts, in such form as may be prescribed by the State Government in consultation with the Comptroller and Auditor General of India. No such format has been prescribed by the State Government even after lapse of more than five years since the Commission started functioning in April 1999.
