**Inviting Application for the post of Electricity Ombudsman**

Gujarat Electricity Regulatory Commission (GERC) invites applications for filling up two posts of Electricity Ombudsman (Ahmedabad & Rajkot). Ahmedabad Office of the Electricity Ombudsman is located at Ground Floor & First Floor, CMTS Building, Telephone Exchange, Bimanagar, Jivandham Road, Ahmedabad and Rajkot Office of the Electricity Ombudsman is located at "Jilla Seva Sadan-3", 3<sup>rd</sup> Floor, Block No.-1, Government Press Road, Rajkot.

According to GERC (CGRF and Ombudsman) Regulations, 2019 the following category of persons shall be eligible to be appointed as Ombudsman:

- i. A retired District Judge; or ii. A retired Secretary to State Government; or
- iii. Any person who has held the position of Member or Chairperson of any statutory quasi-judicial body at the State level for at least 3 years; or
- iv. A retired Chief Engineer or an equivalent officer having experience in the electricity industry preferably distribution business; or
- v. Any officer who has worked in the power sector for at least thirty (30) years in Technical/ Commercial field with at least three (3) years of experience of working in the State or Central Electricity Regulatory Commissions.

The Electricity Ombudsman shall preferably have working knowledge of Gujarati language.

The Ombudsman shall hold office for a period of 3 (three) years. The tenure may be extended for a further period not exceeding 2 (two) years. No person above the age of 65 years shall be appointed as Ombudsman.

The remuneration of the Ombudsman is consolidated Rs.90,000/- per month plus transportation facility.

Interested and eligible persons may apply with full bio-data showing birth-date, educational and professional qualifications and experience and preference for the location as Ahmedabad / Rajkot to Secretary, Gujarat Electricity Regulatory Commission, 6<sup>th</sup> Floor, GIFT ONE, Road 5-C, Zone-5, GIFT City, Gandhinagar – 382 050.
